## § 1. GENERAL PROVISIONS

1. These Terms and Conditions define the rules for providing services by Stellar Models (Michael G. Kozak) based in Poznań, hereinafter referred to as the Agency.
2. The Terms and Conditions apply to cooperation with natural and legal persons, referred to as Talents or Clients, in the field of modeling services and image management.
3. Acceptance of the Terms and Conditions is a prerequisite for commencing cooperation.
4. The Agency may amend the Terms and Conditions. Changes take effect upon publication at [www.stellarmodels.pl](http://www.stellarmodels.pl)

## § 2. SCOPE OF SERVICES

Services for Talents:

1. Career management and representation
2. Organization of castings and photo sessions
3. Contract negotiations
4. Portfolio creation (digital and traditional)
5. Training at StellarModels Academy
6. Social media and personal branding support
7. Digital Twin creation (ELITE package)

Services for Clients:

1. Talent casting (including AI-matching)
2. Campaign and session production
3. Fashion show management
4. AI Influencer rental
5. Digital Twin licensing

## § 3. COOPERATION PACKAGES

BASIC (free)

Profile in database, basic portfolio (3 photos), access to castings, newsletter. 15% commission on contracts concluded through the Agency.

PRO (1,500 PLN net/month + 15% commission)

Everything from BASIC + Talent Manager, extended portfolio (10 photos), contract negotiations, image coaching, social media management, access to training (30% discount).

ELITE (2,500 PLN net/month + 20% commission)

Everything from PRO + Digital Twin, full AI tools, priority casting, advanced analytics, Face to Face 1:1 (1/month), comprehensive social media management (3 posts/week).

Subscription fees payable by the 5th day of the month. Package change with 30-day notice.

## **§ 4. RIGHTS AND OBLIGATIONS**

Talent has the right to:

1. Professional representation
2. Full information about contracts
3. Refusal to participate in a project
4. Control over Digital Twin
5. Termination of contract (§ 7)

Talent undertakes to:

1. Professional behavior
2. Timely attendance at projects
3. Image care
4. Confidentiality compliance
5. Timely payment of fees
6. Not engaging in projects without Agency consent

Agency undertakes to:

1. Professional representation of Talent
2. Active project search
3. Transparent billing
4. Personal data protection (GDPR)
5. Service provision according to package

## **§ 5. DATA AND IMAGE PROTECTION**

1. The Agency processes personal data in accordance with GDPR. The administrator is Stellar Models, Michael G. Kozak.
2. Talent consents to the use of their image in: portfolio for Clients, Agency promotional materials, advertising campaigns (with separate consent).
3. Digital Twin remains the property of Talent. Use requires written consent from Talent.
4. AI-generated content is marked with C2PA metadata (Content Authenticity Initiative).

## **§ 6. REMUNERATION AND COMMISSION**

1. Commission on contracts: PRO - 15%, ELITE - 20% of gross contract value.
2. Remuneration payment occurs within 14 days of receiving payment from Client.
3. Subscription fees payable by the 5th day of the month. Non-payment = suspension of premium services.
4. All amounts are net + VAT.

## **§ 7. TERMINATION OF CONTRACT**

1. The contract may be terminated by either party with 30-day notice (in writing or email: office@stellarmodels.pl).
2. The Agency may terminate the contract immediately in case of: unethical behavior damaging reputation, repeated non-attendance at projects, breach of confidentiality, payment arrears > 30 days.
3. Upon termination, Talent loses access to the platform. Digital Twin remains Talent's property.

## **§ 8. FINAL PROVISIONS**

1. In matters not regulated, the Civil Code and provisions of Polish law apply.
2. Disputes will be resolved amicably. In case of disagreement - court with jurisdiction over the Agency's seat.
3. Invalidity of any provision does not affect the validity of remaining provisions.
